The meeting of the 5-Year Highway and Bridge Plan was called to order by the Chairman in the Commissioner Room at the Court House at Winner on October 11, 2022, at 1:05 P.M. Roll call showed Board members Michael Novotny, Joyce Kartak, Daniel Forgey, Clifford Schroeder and Mark Winter. Also present was Auditor Barbara DeSersa, Roger Sund, Highway Superintendent, Derek McTighe, Brosz Engineering, Inc, Heather Moore, Nancy Richey, Alva Wiley, Larry Wilcox and Larry Harkin.

Derek McTighe, Brosz Engineering, Inc., conducted the meeting by explaining the Five-Year County Highway & Bridge Improvement Plan for 2023. Mr. McTighe explained this meeting is part of the process for the County to qualify for the Bridge Improvement Grant Program and also made mention to the number of bridges in Tripp County (68) and presented inspection reports for those bridges. There will be two bridges replaced in the next 4-5 years. Mr. McTighe said this is an evolving plan and isn't set in stone. Mr. McTighe asked if anyone had any safety concerns or road projects they would like to discuss or see in the future.

Larry Harkin asked about the Keyapaha Bridge and if it is on the 5-Year plan.

Larry Wilcox said North County Road leads to two Communities and there may possibly be a grant for that.

Mr. McTighe explained the grants for asphalt projects are very few. A mile of asphalt that is ground up and re-laid is approximately \$40,000/mile and a mile of asphalt and a 3" overlay costs approximately \$375,000-\$500,000 and everything is going up in price. North County is approximately 15 miles and South County is approximately 26 miles.

Heather Moore asked about a structure in Black Township on 311th Street. Discussion was held.

Alva Wiley and Nancy Richey asked about the Bridge in Rames Township. Discussion was held.

Forgey made the motion, seconded by Schroeder, to approve the 2023-2027 5-year Highway and Bridge Plan.
