A County Initiative Petition an Ordinance Defining the Use of the Automatic Tabulators within Tripp County was given to the Tripp County Auditor on Wednesday April 3, 2024. The County Initiative Petition read as follows:

WE, THE UNDERSIGNED qualified voters of Tripp County in the state of South Dakota, petition that the following ordinance be submitted to the voters of that county for their approval or rejection pursuant to law. The proposed ordinance in proper form is as follows:

AN ORDINANCE DEFINING THE USE OF AUTOMATIC TABULATORS WITHIN TRIPP COUNTY

BE IT ORDAINED by the Board of County Commissioners of Tripp County that the following rules regarding elections in Tripp County, are hereby adopted:

From the effective date of this ordinance, Tripp County ordains that automatic tabulating machine(s)/system(s) are hereby abandoned and prohibited from counting or tabulating Tripp County ballots for any elections in Tripp County as per South Dakota Codified Law "12-17B-3. Authority of governing body to adopt, experiment with or abandon system; Any governing body having supervision of election within any political subdivision may adopt, experiment with, or abandon any automatic tabulating or electronic ballot marking system approved for use by the State Board of Elections. Any governing body may use the system in all or some of the precincts within its jurisdiction or in combination with any other type of voting system approved for use by the State Board of Elections."

The petition was verified and filed in the auditor's office.

Discussion was held on hand counting versus the machine counting. Those attending the meeting are concerned that the elections are not secure using the tabulating machine. Discussion was also held on the post-election audit in SDCL 12-17B-18.

Kartak made the motion, seconded by Forgey, to put the question of hand counting on the primary ballot.
